Rules for the Widowmaker ATV events:

1. Each rider may enter all events.(according to age)
2. All participants must wear helmets and protective clothing(no shorts).
3. All participants must sign waivers on machine and self.
4. Speed limit in pit and staging area is 5MPH and will be strictly enforced.
5. When your class is called you must report to the staging area within 5 minutes or you will be disqualified.
6. No alcohol will be permitted on the Widowmaker grounds.
7. No fires, fireworks, or weapons of any nature are permitted on the Widowmaker grounds.
8. No littering or dumping waste(oil or fuel) will be permitted on the Widowmaker grounds.
9. Judges decisions are final.
10. Each rider will receive two one day tickets with entry.
